The overhaul of Illinois' marriage, divorce, and parentage laws was long overdue. Public Act 99-0090, the rewrite of the Illinois Marriage and Dissolution of Marriage Act ("IMDMA") and Public Act 99-0085, the rewrite of the Parentage Act, were enacted this summer and both are effective on January 1, 2016.

Illinois Marriage and Dissolution of Marriage Act ...

Effective January 1, 2016, the Illinois Marriage and Dissolution of Marriage Act was significantly revised. That was the first comprehensive revision since it first took effect October 1, 1977. Between then and the January date, the legislature tinkered with the Act changing certain parts of it almost annually.

Divorces in Illinois have been governed by the Illinois Marriage and Dissolution of Marriage Act, originally enacted in 1979. Since then, changes in family dynamics, including recent developments in Illinois law related to same-sex marriage, parentage, adoption, and in areas of embryo preservation and rights, rendered the law outdated and in need of an update.
